Symptoms of over-exposure by route of exposure:

The most significant route of occupational overexposure is contact with skin. The symptoms of overexposure to this product are as follows:

Inhalation:

Acute

FIRST AID MEASURES FOR DIFFERENT EXPOSURE ROUTES

Skin exposure:

SPILL AND LEAK RESPONSE

WORK PRACTICES AND HYGIENE PRACTICES
